### **ELIGIBILITY CRITERIA:**

For this **Two-Year M.A. Public Policy** Programme, a candidate should have:

- Graduation in any stream from a recognized university with a minimum of 50% marks (for the General Category) or 45 % marks in the case of candidates belonging to the SC/ST/OBC/EWC category and Specially Abled Person or equivalent CGPA.
- ii. Candidates awaiting results of the qualifying examination can also apply and appear for the Entrance Test, subject to the condition that they produce proof of having passed the qualifying examination at the time of admission.

### NUMBER OF SEATS & RESERVATION POLICY:

The course has **60** (**Sixty**) seats in the Academic Year 2023-2024. The University follows the reservation policy provided by the State Government of Maharashtra and the University.

### **METHOD OF SELECTION:**

The candidates shall be selected based on his/her performance in both, the entrance test and the interview. The candidate will be examined in the following two phases.

### A. ENTRANCE TEST:

All candidates shall appear for the MNLUA Common Admission Test-2023. The Test shall comprise the following components:

.....

- i. A total of 75 marks, consisting of 50 multiple choice questions carrying 1.5 (one and a half) marks each.
- ii. The Entrance Test shall be based on general knowledge of political science and international affairs, law, administrative and management principles, geography, sociology, government policies and various schemes and logical reasoning.
- iii. The Entrance Test shall be of Two Hours followed by an interview.

### **B. INTERVIEW**

The interview shall be conducted online for 25 marks.

### C. APPLICATION FEE

The Application Fee is Rs. 1000 (Non-Refundable) & shall be paid through online.
