UNIVERSITY

The State of Maharashtra realizing the importance of quality Legal Education and the need for well-trained Law Graduates in the Bar and Bench took a decision to establish three National Law Universities in the State of Maharashtra at Mumbai, Nagpur and Aurangabad, in the years 2015, 2016 and 2017 respectively. The Maharashtra National Law University, Aurangabad commenced its operation on March 16, 2017. The commencement of the University has fulfilled the aspirations of the people of the Marathwada Region for an Institution of National Importance. The University visualize to advance and disseminate learning, knowledge of the law, legal processes and their role in national development.

The University aims to develop in the students and research scholars, a sense of responsibility. The objective of the University is to serve society in the field of law by developing skills pertaining to advocacy, legal services, legislation and law reforms. ELIGIBILITY CRITERIA:

To be eligible to appear for admission to the Two-Year Executive M.A. in Public Policy Programme, a candidate should have:

- Graduation in any stream with a minimum of 55% marks or 50 % marks in the case of candidates belonging to the SC/ST category or Persons with Disabilities.
- A candidate who is in service can also apply for the course.
- Candidates awaiting results of the qualifying examination can apply and appear for the Interview Test, subject to the condition that they produce proof of having passed the qualifying examination at the time of admission.


