## **Detailed Notification for the Post of Vice-Chancellor at MNLU, Aurangabad:**

# (A) About the Maharashtra National Law University, Aurangabad:

The Maharashtra National Law University, Aurangabad was established under Act No. VI of 2014 by the State Legislature of Maharashtra. The University commenced its academic activities from March 16, 2017. The campus of the University is situated in a 50 acre area in Kanchanwadi at Chhatrapati Sambhajinagar (Aurangabad). By virtue of the Statute, the Chief Justice of India or his nominee is the Chancellor of the University, and the Chief Justice of the High Court of Bombay is the Pro-Chancellor. The University was established to impart quality legal education and develop advanced clinical pedagogies and research. The University inculcates among its students professional values and dynamism to meet global standards and challenges.

The University is recognised under Section 2 (f) and Section 22 of the University Grants Commission Act, 1956 and is affiliated to the Bar Council of India. Presently, the University is offering various undergraduate and postgraduate programmes in the disciplines of Law, Management and Public Policy. The University offers a Doctoral Research Programme in the disciplines of Law and Management. In addition to this, the University also offers Doctor of Laws (LL.D.), a programme of the highest academic distinction in Law.

#### (B) Call for Applications for the post of Vice-Chancellor:

The Hon'ble Chancellor of this University has constituted a Search Committee to recommend names of suitable candidates for the consideration of the Chancellor for being appointed as the Vice-Chancellor of the Maharashtra National Law University, Aurangabad. The Search Committee invites applications from eminent academicians who meet the requisite qualification and experience required for the post of Vice-Chancellor as prescribed in the 'UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2018'; the 'Maharashtra National Law University Act, 2014' and the Regulations framed thereunder.

Interested candidates may submit their application in the prescribed format only, clearly bringing out their research, teaching and administrative experience/achievements along with the CV and a Vision Statement for MNLU-Aurangabad (not exceeding 1500 words). Duly filled in application should reach the undersigned by email at <a href="mailto:searchcommittee2024@mnlua.ac.in">searchcommittee2024@mnlua.ac.in</a> and a hardcopy of the same to be sent by post duly super-scribing the envelope 'Application for the post of Vice-Chancellor' to 'The Convenor, Search Committee, Maharashtra National Law University, Aurangabad, Paithan Road, Kanchanwadi, Chhatrapati Sambhajinagar (Aurangabad), Maharashtra-431011" on or before April 06, 2024.

The Search Committee shall accord proper weightage to scholastic excellence, exposure to the higher education system in the country and abroad and adequate experience in academic, research and administrative governance. Only shortlisted candidates will be invited for a personal interaction with the Search Committee. The Search Committee shall recommend a panel of three suitable candidates for consideration of the Chancellor for being appointed as Vice-Chancellor of MNLU, Aurangabad. The names of the persons so recommended shall be in alphabetical order without any preference being indicated.

### (C) Eligibility and Terms & Conditions:

The eligibility for the post of Vice-Chancellor is as follows:

- a) The candidate shall be a person who is a distinguished academic with a minimum of ten (10) years of experience as a Professor of Law in a college on post approved by a University or a Professor of Law in a University or ten years of experience in an equivalent position in a reputed research and / or academic administrative organization with proof of having demonstrated academic and administrative leadership and possessing the highest level of competence, integrity, morals and institutional commitment;
- **b)** s(he) shall not be more than sixty-five (65) years of age as on the last date of submission of the application.
- c) s(he) shall have a proven track record of leadership quality and be able to excel the University in teaching and research at the national and international levels.

## (D) Salary and Service Conditions:

- a) The post of the Vice-Chancellor carries a basic pay of Rs. 2,10,000/- (Fixed) with a Special allowance of Rs.11,250/- per month, applicable Dearness Allowance (Existing DA is 46% of the Basic Pay as per the Government Resolution) along with Provident Fund.
- **b)** The Vice-Chancellor is entitled for a rent free accommodation (a semi-furnished Bungalow with such furniture and fixtures as may be approved by the University) on MNLU, Aurangabad campus and no House Rent Allowance will be paid in lieu of the same;
- c) The Electricity Charges, Water Tax and maintenance of official accommodation so provided shall be borne by the University;
- **d)** The Vice-Chancellor shall be provided with necessary staff (a multi-task attendant) at the official residence, a cook and official car with a driver;
- e) The Vice-Chancellor shall be entitled for the reimbursement of the medical expenses incurred on medical treatment as permissible under the Regulations framed by the University, from time to time;
- f) The Vice-Chancellor shall be entitled for telephone services (STD/ISD) at official residence, without any additional charges, along with a mobile phone.
- g) s(he) shall be a full-time salaried officer of the University;
- **h)** s(he) shall hold office for a term of five (5) years or until the attainment of the age of sixty-five (65) years, whichever is early, and shall be eligible for renewal for a further term of five years or till s(he) attains the age of sixty-five years, whichever is early, by resolution to that effect by the Executive Council of the University.

#### (E) General Instructions:

- 1. Applicants shall read all the instructions carefully before applying for the post of Vice-Chancellor advertised by MNLU, Aurangabad.
- 2. The appointment of Vice-Chancellor shall be subject to Rules and Regulations framed by the Regulating Authorities of the University, from time to time.
- 3. Mere fulfilling the eligibility criteria does not confer any right on the applicant to be called for Personal Interaction by the Search Committee.

- 4. Applicants currently serving must send their applications through Proper Channel. Applicants working in University/Institution/College or any other Organization shall submit 'NO OBJECTION CERTIFICATE' along with the application form from the current employer, without which their candidature shall not be considered.
- 5. No interim query shall be entertained.
- 6. No TA/DA shall be paid to the applicants for attending personal Interaction.
- 7. Shortlisted applicants must bring original documents at the time of Personal Interaction for the purpose of verification. Incomplete Application Form or Application form submitted without relevant supporting documents/enclosures (Self attested copies of Degree/Certificates/Marks Sheets/ Experience Certificate etc.) shall not be considered.
- 8. Only shortlisted applicants shall be called for the Personal Interaction.
- 9. Applicants shall have to appear in person before the Search Committee on scheduled date and time only, in case s(he) is invited for Personal Interaction. Request for rescheduling the Personal Interaction will not be considered. No virtual mode of Personal Interaction (Skype, Face Time, Video Conference etc.) shall be permitted.
- 10. The Search Committee reserves the right to alter /update/ modify or withdraw the advertisement-cum-notification at any time without assigning any reason and the decision of the Search Committee in this regard shall be final and conclusive.
- 11. Canvassing or influencing the Selection Process in any manner shall summarily disqualify the candidature of the applicant.
- 12. The Search Committee reserves the right to disqualify any applicant who may have been shortlisted based on wrong information provided by the applicant or by submitting false and fabricated documents.
- 13. Applicant, who has been appointed, based on wrong information/fabricated or false document/s submitted to the University, shall be disqualified and terminated accordingly with immediate effect.
- 14. Applicants having proven track record of academics, research and administration in an institute of international or national repute shall be given preference.

15. Applications shall be made in the prescribed format available at <a href="http://www.mnlua.ac.in">http://www.mnlua.ac.in</a> only. Application made in any other manner shall not be considered at any cost. Applicants are requested to carefully go through the instructions before submitting their applications.

16. The Selected Candidate will be governed by the provisions of the Maharashtra National Law University Act, 2014 and the Regulations framed thereunder from time to time.

17.
