ACADEMIC PROGRAMMES

The University commenced B.A.LL.B. (Hons.) Course from the Academic Year 2017–18. The University started LL.M. (Master of Laws) Course in the Academic Year 2018–2019. The University has also been offering B.B.A.LL.B. (Hons.) Course from the Academic Year 2022–2023.

A) UNDER-GRADUATE PROGRAMMES IN LAW:

I. B.A.LL.B. (HONS.):

Academic Curriculum of the University for the B.A.LL.B. (Hons.), a five year Integrated Degree Course, is inspired by the University Grants Commission's (UGC) Curriculum Development Committee Report (CDCR) wherein the recommendations of the CDC report and the guidelines of the Bar Council of India (BCI), have been considered as the basic parameters to bring it in consonance with trends of globalisation, pluralism and social integration. Clinical Legal Education is an integral component of the academic curriculum of the university through which students understand how to comprehend contemporary socio-legal issues to serve the society at large. The course curriculum promotes interdisciplinary approach of integrating Law, Social Sciences and Humanities. The University follows semester system with six working days in a week, in consonance with the norms of the University Grants Commission and the Bar Council of India, New Delhi. The University introduced Choice-Based Credit Based System (CBCS) for undergraduate degree course.

The students are required to earn a total of 250 credit points spread through out the course of five years; however the students can be allowed to earn more credits from the courses offered by the external experts from time to time. Further, the course structure is designed to impart total 58 (Fifty Eight) papers out of which 48 (Forty Eight) are compulsory papers, 4 (Four) are compulsory clinical papers and 6 (Six) are optional papers.
