

GRADING

The overall structure of the distribution of marks in a theory-based course is such that 25 marks are allotted to mid-semester examinations, while 50 marks are allotted for the end-semester examinations and 25 marks are allotted to project submissions

Each course carries a weightage of either 3, 4 or 5 credits. Semester Grade Point Average (SGPA) weighs the average performance in the semester, whereas the CGPA weighs the same across the academic sessions attended/passed so far. A student will be deemed to have completed the requirements for graduation if he/she has:

a. passed all prescribed courses;

b. CGPA > 5.0, a student having any pending F grades will not be allowed to graduate.
